WHEREAS the "Settlor" is desirous of forming a public charitable trust with an object to construct a suitable marriage/function hall/place for the social benefit of the different sectors of the society and which includes fulfillment of education, medical and cultural needs of the poor people of the society and any other object of general public utility without any profit motive and for the objects specified hereinafter. And whereas the founder trustees have, alongwith the settlor, agreed to act as the **FIRST TRUSTEES** of these presents as testified by their being parties to and executing these present.

AND WHEREAS it is necessary to declare the objects and terms of the public charitable trust, being constituted under these presents.

NOW THIS INDENTURE WITNESSTH AS FOLLOWS:

1. That, in order to effectuate his aforesaid desire, the **Settlor** has set apart and handed over to the trustees, a sum of Rs. 51,000/- (Rupees Fifty One Thousand Only) (hereinafter called the '**Trust Fund**' which expression shall include cash and any other property or investment of any kind whatsoever into which the same or any part thereof might be converted, invested or varied from time to time or which may be acquired by the trustees, and the corpus of the trust fund may be augmented from time to time by the flow of fund by donation and other assets including movable or

immovable and any other kind by way of gifts, donation, acquisition, allotment, grant, exchange or otherwise etc. or may come to their hands by virtue of these present or by operation of law or otherwise howsoever in relation to these present), and the trustee shall hold and stand possessed of the same upon the trust subject to the powers, provisions, agreement and declaration hereinafter contained.

2. **NAME:** The Trust hereby established shall be named as "**MARWARI VIKASH TRUST**".

3. **PLACE:** Office of the Trust shall be situated at O-404, 2nd Floor, City Centre, Luby Circular Road, P.O. Dhanbad-826001, in the District of Dhanbad, or at such other place in India as the Committee of Founder Trustees may from time-to-time think fit.

4. **OBJECT:** The object for which the trust is founded are:

The principal object of the Trust is for relief of the poor, education, medical relief, welfare of the society and the advancement of any other object of general public utility without any profit motive and includes:

- To acquire land by way of purchase/donation from the sellers/donors and to construct a suitable marriage/function Hall/place for the society to achieve the objects of the trust.
- To construct, maintain, run, aid, provide grants or otherwise assist hospitals, medical colleges, nursing homes, dispensaries, clinics, maternity homes, child welfare centres, diagnostic centres including alternate therapies like homeopathy centres etc. in India, along with medical facilities including providing ambulance facilities, health check-up centres, diagnostic centres, health care camps for the poor and needy person of the society.
- To establish, maintain and run schools, colleges and universities, laboratories, research and other institutions, for school coaching centres, Social Service Centres, Vocational training centres, allied education institution undertaking the research on arts, science and region.
- To construct, maintain, develop and renovate Public place, old age homes, Dharamsala, Marriage Place, Yatri Nivas, guest house, orphan houses, widow houses, poor houses, alm houses, temporary guest houses for tirtha yattris, ganga sagar yattris, cavarlahs or the other persons on different melas, mahotsav, or any other occasion as well as gaushalas, panshalas, and such

other place which is incidental to or required to augment the object of the Trust.

- To start organize, construct and maintain boarding houses, hostel, play ground, auditorium, swimming pool, aerobic centre, gym for students and other health centres for achieving the object of the Trust.
- To establish cultural and social institutions alongwith free public reading rooms and libraries.
- To grant financial assistance to any educational institution for granting scholarship, prizes, medals and awards for excellence in studies, sports and other scientific research, free distribution of books and notebooks for poor and deserving students.
- To establish research and training centres for the furtherance of education/ learning in its various fields and to undertake propaganda, training and education of the masses either of its own or in co-operation with similar agencies working for the cause of all round development of the society.
- To bring, publish and sell, distribute books, periodicals, leaflets, brochures and papers, and to train people to impart true education in spiritualism and also to open and maintain libraries, reading rooms for the promotion of the objects of the Trust.
- To confer title on eminent personality in the field of science, arts, commerce, education and literatures, sports etc.
- To establish the colleges to impart education in the area of higher education especially the emerging fields like Electronic, Bio-technology, software, hardware, E-Commerce and other allied fields.
- To spread for promotion of education and learning in all branches more specifically in science and technology, along with eradication of social evils such as dowry, child marriage, untouchability, drinking, smoking, drug abuse or any other abuse or social evils.
- To provide amenities for holding discourses on Indian and/ or Western philosophy and allied subject touching upon Tradition and the way of life.
- To train teacher and workers in ideals and practice of the true spirit of the education and learning and to carry out awareness programs relating to AIDS and other diseases.
- To provide relief to the poor including grants or aids such as food, clothing, shelter or other facilities to the victims of floods, Tsunami, Earthquakes, droughts famine, fire, riots, or any other natural calamities.

- To provide relief and help to the aged, blind, lame, deaf, dumb, orphans, and persons otherwise disabled or incapable of earning their livelihood or any one or more of them by grants and aids, (financial or otherwise) and/or maintenance, or establishments and support of institution and homes for the benefits of such persons.
- To provide relief and assistance in marriage of poor and needy children and persons of the society.
- To provide drinking water centre or facilities for the public at large.
- To function as a non communal Trust and as a secular organization.
- To establish center for employment generation and also to organize seminars for awareness of the people at large.
- To acquire and maintain the movables / immovable properties for achieving the objects of the organization.
- To advance any other object of general public utility which may include activities such as rural development including construction , maintenance of road, culverts, bridges, irrigation tanks as well as to construct, repair and manage marghats, cemeteries and burial grounds.
- To aid/assist by way of donation for the renovations or repair of prayer hall, temples, mosques, churches, gurudwaras, or the other place as notified by the Central Government in the official Gazette for the purpose of Section 80G of the Income Tax Act, 1961, to be of historic, Archeological or artistic importance or be as place of public worship or renowned throughout in any state or states of India.
- To construct, maintain, develop and renovate the places of worship, prayer hall, meditation halls etc.,
- To organize educational, spiritual, religious, or other discussions, discourses and teaching etc.
- To apply the CSR fund received from companies/organizations in accordance to the provisions of the Act towards the object of the Trust.
- To apply surplus of the trust to achieve the object of the trust with the prior approval of the Committee of the Founder Trustees.

The Trust shall be an irrevocable educational, cultural, public religious trust for the benefit of all person belonging to whomever community irrespective of caste creed or religion. The Trustees shall stand possessed of the said amount of corpus endowed by the Authors of the Trust and such other properties (both

movable or immovable) as may be acquired from time to time by the Trust, by purchase, exchange, grant, allotment subscription, endowment, donation, contribution, or in any manner whatsoever (all of which shall be designed as Trust properties) on the Trust herein mentioned.

5. CATEGORIES OF TRUSTEES:

There shall be three categories of TRUSTEES:

• **FOUNDER TRUSTEES:**

Founder Trustees shall comprise of the Settlor and the Founder Trustees as stated hereinabove and other Founder Trustees as may be included from time to time. Total number of the Founder Trustees shall be limited to 500 (five hundred), which may be increased from time-to-time with the prior approval of Committee of Founder Trustees by a resolution passed by a majority of atleast 50% present and voting in a meeting wherein atleast 20% of the existing committee of Founder Trustees are present. All the 500 (five hundred) Trustees mentioned in this deed and appointed from time to time are/shall be the **Founder Trustee**. Founder Trustee may nominate his/her spouse or children or grandchildren as Founder Trustee in his/her place in case of retirement or death.

In case of death of a Founder Trustee without any such nomination, the family of the Trustee {consisting of deceased's spouse, son(s) and daughter(s)} shall nominate any one member of the family unanimously decided from amongst themselves as a Founder Trustee in place and instead of deceased Trustee within one year from the death of the Trustee.

Such nominated Trustee shall also be deemed to be the Founder Trustee and shall have all rights, power and duties of the Founder Trustee.

• **LIFE TRUSTEES:**

A life Trustee is a person who is nominated by the Committee of Founder Trustee as a life Trustee for his/her lifetime.

The appointment of the life Trustees shall be the discretionary power of the Committee of the Founder Trustees and they may appoint or nominate any person or persons contributing a donation of a specified amount as decided by the committee of the Founder Trustees as life Trustees from time to time. The total number of Life trustees shall be unlimited.

- **HONORARY TRUSTEES:**

Honorary Trustee is a person who is nominated by the Committee of Founder Trustees as an Honorary Trustee.

The Committee of the Founder Trustee may appoint any person or persons as a Honorary Trustee of eminence, or any person who has rendered eminent service to the trust, or who on account of his positions or connection, or any other person in a position to render valuable help and services and advice to the Trust or may be considered useful to the cause and objects of the trust. He/she shall be appointed as Honorary Trustee for a period of one year at a time, subject to re-appointment by the Committee of the Founder Trustee. The total number of Honorary Trustees shall not exceed 5(Five).

6. COMMITTEE OF FOUNDER TRUSTEE:

- The Committee of Founder Trustees shall have all Founder Trustees (including Settlor) as its members.
- The Committee of the Founder Trustees shall ordinarily meet once in 3(Three) month or as often as may be necessary for the satisfactory conduct of the affairs of the Trust.
- The Committee of the Founder Trustee shall have the sole power to appoint the trusteeship of all three categories of the Trustees. In case of appointment of:
 - i. A Founder Trustee, a resolution passed by a majority of at least 50% of the Founder Trustees present and voting, in a meeting wherein at least 20% of the members of the existing Founder Trustee Committee are Present.
 - ii. A Life Trustee, a resolution passed by a majority of at least 50% present and voting in a meeting wherein at least 20% of the member of the existing Founder Committee are present,
 - iii. A Honorary Trustee, a resolution passed by a majority of at least 50% present and voting in a meeting wherein at least 20% of the members of the existing Founder Committee are present.
 - iv. The Committee of Founder Trustees shall have the sole power to terminate the trusteeship of Honorary Trustee with a resolution passed by atleast 50% majority in a meeting wherein at least 20% of the members of the Founder Trustees are present.

v. The Committee of the Founder Trustees by a two-third majority of fifty percent of the total strength of the Committee of Founder Trustee shall have the special power including any amendments to this trust deed notwithstanding anything contained in this deed. The final decision on all the matters is vested with the Committee of Founder Trustees to over-rule any decision taken by the Board of Trustees and shall be the final decision on all aspects and shall be binding.

7. **BOARD OF TRUSTEES:**

- The day to day affair of the trust shall be managed by the Board of Trustees consisting of not more than 51(fifty one) trustees. The Board of Trustees shall consist of not more than 40(forty) member from the Founder Trustees, not more than 10(ten) from the Life Trustees and not more than 1(one) from the Honorary Trustees. Further first Board of Trustees shall consist of only founder trustees which shall not be more than 51 (fifty one).
- The term of the Board of Trustees shall be for **two years**.
- The Board of Trustees shall Nominate or Elect a President, a first Vice President, a Second Vice President, a Secretary, Two Joint Secretary, a Treasurer, a Joint Treasurer and five advisors from amongst themselves. Such persons shall be collectively termed as "**Office bearers**". The remaining trustees of the Board shall be termed "**Executive Trustees**".
- Once a trustee becomes a member of the Board of Trustees for two consecutive terms, such trustee shall not be eligible to become a member of the Board for the immediate next term if he had become an Office bearer in any capacity during any such two consecutive terms.
- The powers, functions, duties and responsibilities of the constituents of **Office Bearers** and **Executive Trustees** shall be determined by the Committee of Founder Trustees through specific clauses in the bye-laws of the Trust.
- The meeting of the Board of Trustees shall be presided over by the President and in his absence Vice President will preside.
- The Committee of Founder Trustees shall re-constitute the Board of Trustees every two years after the expiry of the said term of two years.
- The Board of Trustee shall meet every two month or as frequently as required.
- The President shall have power to cast vote in the event of equality of votes.
- Honorary Trustee shall not be entitled to cast a vote.

- Founder Trustees and Life Trustees representing the Board of Trustees shall be elected by the Founder Trustees and Life Trustees respectively. Further, Honorary Trustee representing to the Board of Trustees shall be elected by the Committee of Founder Trustees only.

The first Board of Trustees shall be as follows:

The Settlor and Trustees who are signatories to this deed shall together form the first board of trustees.

The First Board of Trustees shall hold Office till the formation of the Board of Trustees as mentioned in the Trust deed here in above.

Termination/Removal of a board member:

A member of the board including the Office bearers can be removed before the expiry of his/her term at an Extra-ordinary General Meeting by a resolution passed by majority of atleast One-third of the Founder Trustees present and voting in a meeting wherein atleast 50% of the existing committee of Founder Trustees are present.

8. APPOINTMENT OF TRUSTEE:

Appointment of Trustees of all the three categories shall be at the sole discretion and decision of the Committee of the Founder Trustees only.

9. VACANCIES:

Vacancies in any of the three categories of the Trustees, namely, founder, Life and Honorary trustees can only be filled up by the Committee of the Founder Trustees.

10. TERMINATION OF OFFICE OF THE TRUSTEES:

A Founder Trustee or a life Trustee or an Honorary Trustee shall cease to hold office:

- If he dies
- If he resigns
- If he is adjudged insolvent or found guilty of an offence involving moral turpitude
- If he is found to have acted against the interest of the Trust
- If it is unanimously decided by the Committee of the Founder Trustees that his continuation in the office is against the interest of the Trust
- If he is found insane
- If he is found guilty of grave offence and convicted by any court of law.

11. GENERAL MEETING OF THE TRUSTEES :

General Meeting of the trustees shall be organized once in a year i.e. within six months from the end of financial year, i.e. 31st March or any other date as notified by the Government of India, to deal with annual financial accounts and the budget for the coming years. Trustees from all the categories shall be entitled to attend the AGM / EGM. EGM shall be held from time-to-time to consider any special object required for the trust. EGM shall be called for on a petition of atleast one-tenth of the existing Founder Trustees.

12. MEETING OF THE BOARD OF TRUSTEES:

The Board of Trustees shall necessarily meet once in two month or as often as may be necessary for the satisfactory conduct of the affairs of the trust.

13. NOTICE:

Seven days Notice shall ordinarily be given in writing for a meeting of Board of Trustees or Committee of Founder Trustees. However, a shorter notice may be given during any emergency holding of meeting of board of trustees or Committee of Founder Trustees.

14. QUORUM:

- The Quorum for the Meeting of the Board of Trustees Shall be one third of the actual strength of the Board of Trustees.
- The Quorum for the meeting of the Committee of Founder Trustees shall be one tenth of the actual strength of the Committee of Founder Trustees.

15. MINUTES:

A minutes book shall be kept at the office of the Trust. Appointment/removal of Trustees and all proceeding of the meeting of the Board of Trustees and Committee of Founder Trustees shall be recorded in the minutes book and shall be signed by the President of the meeting.

 2. To construct and maintain building, to alter, to demolish or improve them and equip them suitably.
 3. To accepts Gifts, donations, endowment and contribution for the trust.
 4. (a). To receive monies, securities or other movable property on behalf of the Trust.
(b). To accept any trust, trust fund or endowment so long as the provisions of such Trust or endowments are in consonance with the object of this Trust.

 6. (a). to enter into contracts or engagements on behalf of the Trust or

14. Out of the income of the trust property the Trustee shall be entitled to spend or incur the following expenses namely:
 - (a) All rates, taxes, cess, assessments, dues and duties if any payable to the government, municipal or other public bodies in respect thereof or any part thereof.
 - (b) the premium for the insurance of the building or any insurable property movable or immovable for the time being forming part of the trust property.
 - (c) the costs of ordinary repairs and for providing any amenities to the building for the time being forming part of trust property.

After deducting the costs, charges and expenses incurred by the trustees as aforesaid out of the total gross income received by them from the trust property, the balance, i.e., the net income will be utilized for the object of the trust as decided by the board of Trustees with the prior approval of Committee of founder Trustees.

18. BORROWING:

The Board of Trustees shall have power to borrow funds if needed against the security of the assets of the Trust or otherwise by way of Bank overdraft, loan or otherwise, from banks, financial institution or any other person or institution as may be necessary, for the benefit of the trust and for more effectively carrying out the object of the Trust with the prior approval at the meeting of the Committee of the Founder Trustees.

19. INVESTMENT:

The Board of trustees shall have the power to invest the funds in the best possible manner except personal loan to any trustee/employee/other persons with a view to augment the resources of the trust to be able to better fulfill the object of the trust, but the trust will not embark on any business or invest in any speculative venture. Such investment will not deviate from the requirements of any law relating to public trust or law relating to exemption under the Direct Tax Laws. Further, all investments shall be made with the prior approval of the Committee of Founder Trustees.

20. SPECIAL POWER TO THE FOUNDER TRUSTEES:

Notwithstanding anything contained in this deed, the final discretion on all the matters is vested with the Committee of Founder Trustees.

The Board of Trustees may open such Bank Account or Accounts in any of the Bank in the name of the TRUST. Such accounts shall be jointly opened by the President, Secretary and Treasurer of the Board of Trustees and operated by any two of them jointly, who will be authorized to sign the documents required to be signed on behalf of the Trust.

22. APPLICATION OF THE PROPERTIES OF THE TRUST:

The properties and funds of the trust shall be applied only for the purpose of the trust and for the due administration of its affairs and the trustees will not be entitled to any remuneration, save right to reimbursement of expenses incurred in the discharge of their duties. Neither the Settlor/Trustees, nor their families (consisting of spouse, son and daughter), will be entitled to any benefit prohibited by the applicable provisions of direct Tax Law in India or otherwise directly or indirectly from the trust.

23. ACCOUNTS:

The Board of Trustees shall maintain a true and correct record of the receipts, payments, income and expenditure and transaction of the trust. The books of accounts of the trust shall be audited by practicing Chartered Accountant every accounting year i.e. commencing from 1st April to 31st March or every financial year as adopted by Union of India. Such auditor shall be appointed at the AGM of the Trust.

24. SUB COMMITTEE:

The Board of trustees will be entitled from time to time to form or dissolve Sub-Committee for carrying out any of the provisions of these presents and the persons who are not members of the Board may also be appointed as member of such sub-committee.

25. AMENDMENTS:

No amendments to the trust Deed shall be made which may prove to be repugnant to the provisions of section 2(15), 11, 12 and 13 and 80G of the Income Tax Act , 1961 and analogous provisions of the Direct Tax Law now or as may be amended from time to time. The committee of the Founder Trustees is empowered for amendments of this Trust Deed with majority of two third of the Fifty percent of total strength of the Founder Trustees.

26. SAVING CLAUSE:

27. THIS TRUST IS DECLARED IRREVOCABLE:

The President, Secretary or Treasurer may sue and be sued in the name of the Trust.

29. RESOLVING DISPUTES:

If any doubt arises about interpretation of this deed or about duties, the matter shall be referred to a three member arbitration committee consisting of trustees to be decided by Committee of Founder Trustees and their decision shall be final and binding to all.

30. DISSOLUTION:

In the event of dissolution or winding up of the Trust the assets of the Trust remaining on the date of dissolution shall under no circumstances be distributed amongst the Trustees, but the same shall be transferred to other Trust, society, Association or Institution whose objects are similar to those of this Trust.
